Axinn in action

Agribusiness: Tyson Foods

Axinn represents Tyson Foods in the defense of multiple litigations claiming industry-wide conspiracies to raise the prices of broiler chickens, pork, and turkey, as well as to depress broiler grower pay. The *Broiler Chicken* litigation alone is historic in its size and scope, involving three classes, well over 100 direct action plaintiffs, follow-on State AG litigations, and concurrent regulatory investigations. After three years of strategic litigation and positioning by Axinn's team, Tyson secured an advantageous resolution of all the *Broiler* class claims in late 2020. Axinn then negotiated cost-of-litigation class settlements in both the *Turkey* and *Growers* litigations in the first half of 2021. Axinn continues to litigate against direct action plaintiffs in the *Broilers* and *Turkey* litigation, and against all plaintiffs in the *Pork* litigation.

Technology: Google

Axinn defends Google in antitrust cases brought by a Texas-led group of State AGs and private plaintiffs challenging Google's ad tech business under the Sherman Act and various state antitrust, consumer protection, and deceptive trade practices statutes. Axinn's team brings deep subject matter experience to the cases and has a key role in all phases of the litigation, including recently securing dismissal of several parts of the State AG complaint (including a Section 1 Sherman Act claim).

The Texas-led case was named *Global Competition Review's* 2022 Behavioural Matter of the Year – Americas.

Pharma: Momenta

Axinn served as lead counsel for Momenta in two antitrust cases alleging that Momenta and its co-defendant, Sandoz Inc., excluded a generic maker of Sanofi's blockbuster anticoagulant drug, Lovenox®. This litigation, a follow-on suit from a patent litigation brought by Momenta and Sandoz, raised cutting-edge, complex antitrust issues regarding the bounds of antitrust liability for the alleged deception of a standard-setting organization. Axinn successfully resolved the claims against Momenta for a small fraction of the damages sought.

Consumer Products: Stanley Black & Decker

When SawStop alleged that our client and other saw manufacturers had conspired to boycott proprietary safety technology, Axinn found an efficient avenue to thwart the claim. According to SawStop, the alleged boycott was carried out through an industry group joint venture. But the DOJ had published notice of this joint venture in 2003 — 11 years before the suit was filed. The district court agreed with our argument that the claim was time-barred by a four-year statute of limitations and summarily dismissed it, a ruling that the US Court of Appeals for the Fourth Circuit unanimously affirmed.

Healthcare: University of Pittsburgh Medical Center

Axinn served as lead counsel for our client, one of the largest integrated hospital and health plans in the United States, in its defense of antitrust claims by a former vendor regarding one of the client's subsidiaries. The district court granted our motion for summary judgment on all six antitrust counts, including allegations of conspiracy, group boycott, monopolization, attempted monopolization, and exclusive dealing. The Third Circuit affirmed the summary judgment win the following year.

Life Sciences: RelayHealth (a wholly owned subsidiary of McKesson Corp.)

Axinn served as lead counsel for RelayHealth in a treble-damages class action litigation that followed an FTC investigation and civil action alleging monopolization by the healthcare technology company Surescripts. While navigating the ongoing FTC litigation and an order of early production of FTC investigation documents, the Axinn team successfully positioned RelayHealth to secure an early resolution for an amount not material to the company's financial results. The court granted final approval of the settlement agreement on February 24, 2022, and declined to dismiss the case against the remaining defendants.

Nonprofit: Alliance for Safe Online Pharmacies

Axinn secured early summary judgment in favor of its client Alliance for Safe Online Pharmacies (ASOP), dismissing it from an antitrust suit alleging that ASOP and other organizations engaged in a conspiracy to prevent PharmacyChecker.com (PCC) from accessing internet platforms to promote the importation of pharmaceuticals from outside the United States. ASOP is a nonprofit organization that seeks to protect patients from counterfeit drugs by ensuring access to legal and legitimate online pharmacies. Axinn's team was instrumental in winning early and exclusive discovery into the legality of PCC's organization, which led to the court's conclusion that because PCC's enterprise is "completely or almost completely geared towards facilitating illegality," PCC had no standing to bring its Sherman Act claim. The case is an important affirmation of the ability of organizations such as ASOP to educate consumers about the dangers posed by illegitimate online pharmaceutical vendors and facilitators.

Healthcare: Independence Blue Cross

Axinn serves as lead counsel for Independence Blue Cross in multidistrict litigations and several opt-out proceedings in the United States District Court for the Northern District of Alabama. The plaintiffs include putative classes of certain Blue Cross and Blue Shield subscribers and medical providers as well as numerous fully-insured and self-funded plan opt-outs. Defendants, including Independence Blue Cross, settled with the downstream subscriber class for \$2.67 billion, while litigation with the putative provider class is still ongoing. In one of the opt-out proceedings, Independence Blue Cross was one of the Blue Plans that succeeded in challenging the jurisdiction of the California state court to exercise specific jurisdiction over it, and won a dismissal of those claims in 2022.
