Arthur J. Gallagher & Co., one of the most significant transactions in the U.S. insurance brokerage market. These nominations recognize creative, strategic, and innovative competition work on a landmark merger control matter in each region.

The finalists were chosen by *Global Competition Review*'s editorial team, with winners determined by an online vote of GCR readers. [Readers can vote here until February 9th.](#)


The winners will be announced at GCR's 16th Annual Awards Ceremony on March 24th in Washington, D.C.
