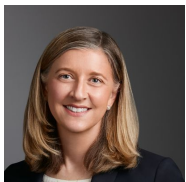

Both Maier and Murata are thought leaders in their respective fields, with numerous publications and speaking engagements to their credit. They are also active members of the

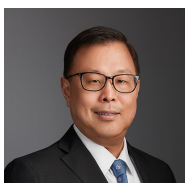
American Bar Association and other legal/professional societies.
